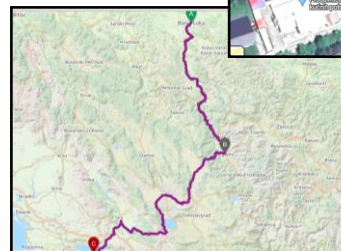

Location:



The company is situated at the same location as the former military industry "Slavko Rodić" Bugojno, which is today's industrial zone in Bugojno, on the transit route Banja Luka - Split.

Products:



Our production range currently includes positions obtained by processing/cutting on lathes, and we plan to expand it to the field of milling on milling machines.

We create positions based on the customer's documentation or submitted samples.

Machinery:

We currently possess four CNC machines for material processing through cutting: Index ABC, Index GE 42 and Poly Gim Diamond CSL. The best results are achieved below the 35 mm diameter of manufacture. We also own a machine for finishing positions. We have a five-axis lathe.



Quality:

The company currently doesn't possess the ISO 9001 standard for quality management. However, the employees are regularly taught on the importance of the standard for quality assurance.



We have access to the necessary measuring equipment and devices in order to ensure the quality required by our customers (coordinate measuring 3D machine, contourograph, machine for measuring roughness, profile - projector).

Services:

In addition to cutting by scraping, we also performed metal grinding, as well as welding and assembly of individual structures, thus expanding the range of activities.



The quality of the work must be unquestionable, as well as the fact that the quantities and given deadlines set by the customer are in the first place and we regularly meet them.
